Increase Productivity - Why it Matters Productivity is a really hot topic right now - no doubt because people are starting to become more aware of their own productivity. So it's important to take a look at it from a 'Big Picture' perspective. You probably have an idea about what it is, but take a moment to really think about what you do (or don't do) to increase your productivity. Most of us spend a lot of time in our jobs working on a project or some other set task. For most of us we go through a daily work loop in which we do some tasks, mark them off the task list, and then move on to the next. The problem with this type of workflow is it's boring and all too often is so in-depth that we don't actually do any real meaningful tasks. We do more processing on big tasks with ever-decreasing efficiency, so that in the end we do actually do less than we would have if we did the same things in smaller chunks. The problem is that most of us don't really consider that we could be increasing our productivity with tools we already have in the studio, tools that we are probably using already, but which we are perhaps not taking advantage of to the extent that we could. In the realm of Photoshop, these are a few of the most important tools to be aware of that can

increase our productivity: Faster means better It is important to remember that Photoshop's most famous processing tool, the scalpel, is actually used for more than just manipulating pixels. The scalpel is very powerful for tiny, precise changes to your photo. But it's surprisingly inefficient when you're changing larger areas of image and the process is slow, which means you're making very small changes (or even not at all) and then moving on to the next small section of the photo. In the most extreme case I've seen it was a photo of a washing machine that was being emailed around with rather poor results. Each step of the processing on the photo's layers was taking several hours. If you can do an entire project at once and a lot of the work is done in one go, you can end up with massive time savings as opposed to doing it in small chunks.
